*Option C – To assess whether the arrangement is appropriate, an AIL staff member will conduct an interview with the parent nominated host and assess the property providing Homestay accommodation for you. Once accommodation is approved by AIL, your contact details and the details of your nominated friend or relative are sent to a Homestay agency for registration. The Homestay agency will send an invoice for the registration/placement fee to you. Once paid, the agency will contact the nominated Homestay and organise a date to register the host family. This procedure includes a site visit of the accommodation and obtaining Working with Children Checks for all adults living on the premises. Please note, AIL will charge an assessment fee for this option.			
CAAW CONDITIONS AND STUDENT RESPONSIBILITIES			
Under CAAW arrangements, students must:

Seek approval from AIL before making any changes to accommodation or welfare arrangements. 4. Attend scheduled welfare meetings with AIL's Student Support Team. 5. Provide flight arrival details to AIL and their accommodation provider. 6. Travel approval: Obtain written approval from both AIL and a parent/guardian before traveling outside Melbourne.

PRIVACY STATEMENT

PERSONAL INFORMATION

STUDENT VISA CONDITIONS

Under Australian Government regulations all overseas students must be enrolled for, and engaged in, full-time study, unless on a spousal visa.

Overseas Student Health Cover (OSHC) is compulsory for all overseas students while studying in Australia. OSHC does not cover optometry, dental services or pre-existing conditions (i.e. prior to entry into Australia).
